### 2025 Budget Highlights: **Investing in Our Community's Future**

Over the past several months, we have been diligently working to develop a balanced 2025 budget that upholds our commitment to providing high-quality services for our Township. Fortunately, our community has benefited from growth, which has helped offset some of the increased costs.

This budget addresses key financial challenges, including the need to invest in essential infrastructure projects and maintain aging assets. As our population grows, it's crucial to support these needs and ensure our infrastructure remains in good condition. To help fund this, a new Development Charges (DC) study in 2025 will align fees with today's needs. We're also adopting a proactive asset management strategy aimed at meeting annual replacement requirements within the next six years, ensuring our assets are renewed as they reach the end of their lifespan and that funds are available when needed, rather than placing a financial burden on future generations. With that in mind, \$15.75 million—approximately 30% of the operational budget—is being invested into reserves for future capital expenses. These are significant steps to ensure our community's future is supported by longterm, sustainable financial planning.

Aligned with our Human Resources Plan, this budget provides departments with resources to meet the evolving needs of our community. Enhancements to Fire Services are also a priority, reflecting resident and Council support for a safer community.

The budget includes an average household tax increase of \$15 per month in 2025, instead of the \$19 per month initially discussed at the start of the budget planning process. Of this amount, one-third (\$5) is allocated solely to cover the increased fees for annual OPP policing services in our Township. It is important to note that the Township has no control over these OPP fee increases, as they are determined externally. Balancing these needs has been challenging, as each department plays a crucial role in maintaining the quality of life of our Township. This budget reflects our commitment to addressing immediate needs while ensuring long-term sustainability, and we're confident that through strategic planning and ongoing collaboration, we can build a secure future for our community. # **Winter Parking**

From November 1, to April 1, there will be no nightly on-street parking ban. Instead, street parking restrictions are alert-based throughout the winter. This means that residents can park on the street overnight unless a Winter Parking Ban Alert is issued.



An alert will be issued when 5cm or more of snow or freezing rain is in the forecast, and will be sent out by 2:00 p.m. restricting on-street parking from 1:00 a.m. to 7:00 a.m. These alerts are sent to our subscribers by email, posted on social media (Facebook, Instagram and X) and on our four LED Boards.

Important: To be notified, please register for parking ban alerts at *Russell.ca*/ Subscribe.

During a winter parking ban, you can park at one of four designated parking areas between 7:00 p.m. and 7:00 a.m.

- Camille Piché Community Centre, in front of the skate park (8 Blais, Embrun)
- Richelieu Park, west side (159 St-Moritz Terrace, Embrun)
- Russell park-and-ride parking lot, east side (1st Avenue, Russell)
- Duncanville Park, north side (1141 Concession, Russell)


#### New 2025 Collection Calendar

#### **Winter Reminders**

- 1. Move your basketball net off the street. It should not be within the road allowance.
- Keep snow on your property, and don't push it into streets, sidewalks, or in ditches (as per the Highway Traffic Act).
- 3. You'r garbage and recycling bins need to be visible in your driveway, and not on the street, shoulder, or sidewalk.
- 4. To avoid shoveling the driveway again when the plow passes by, clear the area to the left of your driveway. Snow from the plow will be pushed in that area instead of inside your driveway.
- 5. Keep fire hydrants clear of snow for emergency services.
- 6. Keep your distance from snowplows! When plowing an intersection, the truck needs space to back up.
- 7. Respect winter parking restrictions.
- 8. Winterize your mailbox with a barricade to protect it from the force of thrown snow from a plow blade.

# **New Provincial Policy Statement (PPS)**

The PPS 2024, the foundation of Ontario's land-use planning, is now in effect and requires all municipal planning to align with it. For our Township, this affects development, severances, settlement areas, and more. While you may primarily engage with the Township's Zoning By-Laws and Official Plans, the PPS guides the underlying principles of these policies.

The Provincial Government highlights key objectives of the PPS 2024, enabling municipalities to:

- · Support development and increase housing supply
- Align development with infrastructure for a stronger economy
- Ensure rural viability
- Protect agricultural lands, the environment, and public health

# Tempo Shelter Season

A Tempo shelter is defined as a temporary structure featuring a metal frame covered by a tarp or similar fabric, primarily used for the storage of vehicles or equipment associated with residential use.

Residents may install Tempo shelters in their front, interior or exterior yards starting from November 1 of the current year. Removal must be completed by April 1 of the following year.

When installing:

- In a front or exterior side yard, ensure it is set back at least 1 metre from the lot line.
- In an interior side yard, it must be placed at least 0.5 metres from the lot line.

Please ensure that the Tempo does not create visibility issues or compromise safety at any time.
