#### <u>Strategies already in place:</u>

#### From 2020 to 2028:

- \$150,000 annual allocation increase from new growth generated tax revenue
- 1% tax increase on a yearly basis

#### From 2022 to 2028:

• Surcharge on registration on arena rentals and pool facilities until new facilities are available in 2026
