Fences needs to be at least 1.2 m (48 inches/ 4 feet) high. No spaces greater than 4 inches permitted. For chain link fences, no greater than 2 inches per link. No fence is required if pool height at least 48 inches (4 feet / 1.2 meters) in height and has no bubble shape (inflatable) walls or diagonal bracing.

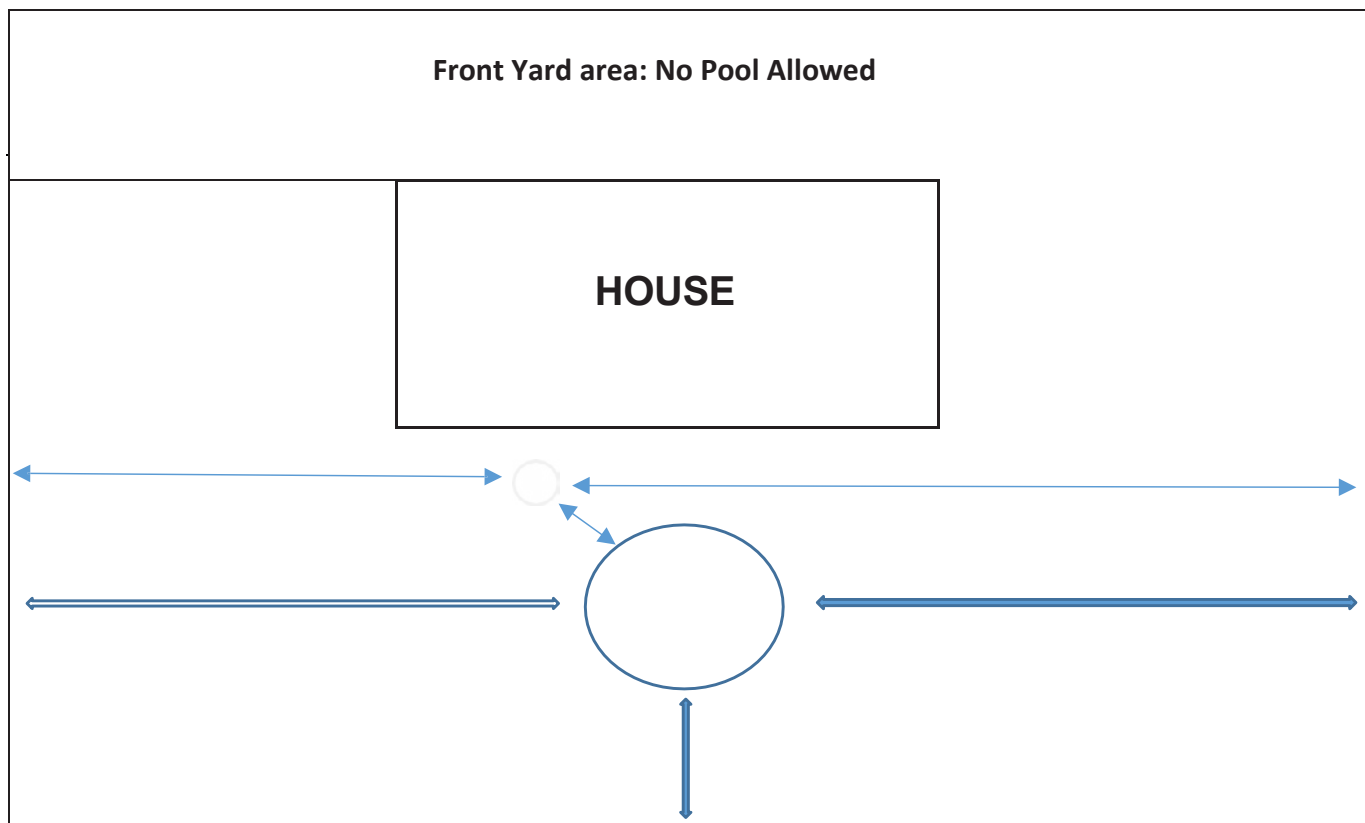
