2025 ANNUAL REPORT

Under ss.68(1)(f) of the Community Safety and Policing Act, 2019 (CSPA), most of which came into force on April 1, 2024, the Board is required to provide an annual report to Municipal and First Nations Councils regarding the policing provided in our communities by the Russell County OPP Detachment.

This report is divided into three sections:

1. **Russell County OPP Detachment Board Report** (Pages 1-11): The 2025 Annual Report outlines the governance, oversight, and key activities of the Russell County OPP Detachment Board, for the year 2025. Key highlights include the full establishment of the Board with municipal, community, and provincial appointees, progress on governance policies and training, and strengthened oversight through regular crime and policing reports. The Board supported community safety initiatives, victim services partnerships, and local fundraising efforts. The report also presents the 2025 operating budget, confirms municipal cost-sharing, and identifies future priorities focused on improved governance, performance evaluation, transparency, and continued collaboration to support safe communities across Russell County.
2. **Russell County OPP Detachment 2023-2025 Action Plan** (Annex A): This plan outlines policing priorities for 2023–2025, aligned with the OPP Strategic Plan [Ontario Provincial Police - OPP 2023-2025 Strategic Plan](#) and focused on crime reduction, road/waterway/trail safety, and community well-being. Key priorities include preventing violent and property crime, addressing illicit drugs and cybercrime, and improving traffic safety by targeting the “Big Four” collision factors (impaired, aggressive, inattentive driving, and lack of restraints). The plan emphasizes community partnerships, enhanced mental health co-response, strong support for Auxiliary members, and a continued commitment to member

wellness, training, and professionalism to support safe, resilient communities across Russell County.

3. **Russell County OPP Detachment 2025 Annual Report** (Annex B): The 2025 Russell County OPP Detachment Annual Report outlines policing activities, priorities, and outcomes for the final year of the 2023–2025 Action Plan. Overall, property crime showed a downward trend, while violent crime remained relatively stable. Traffic safety initiatives targeting impaired, aggressive, and inattentive driving contributed to reductions in collisions, injuries, and fatalities. The detachment handled nearly 20,000 calls for service and continued to prioritize victim support, mental health response, and community engagement. Ongoing collaboration with partners and investment in officer training and technology supported effective service delivery and community safety.

LETTER FROM THE CHAIR



This year has been one of important progress and continued maturation for the Russell County OPP Detachment Board.

Serving the municipalities of Russell, Clarence-Rockland, The Nation, and Casselman, our Board remains committed to strengthening the relationship between the Ontario Provincial Police, municipal partners, community organizations, and the residents we serve.

It keeps the Board focused on governance-level responsibilities such as Local Action Plan implementation, quality of reporting, community engagement, strategic response to local safety trends, and detachment-level outcomes — while remaining clearly outside operational policing decisions.

The Board also reviewed the 2026–2029 OPP Local Action Plan, which will guide our shared priorities in the years ahead. This plan reinforces the importance of proactive community presence, road safety, visibility in our schools, support for vulnerable residents, and collaboration with local partners. These priorities reflect the realities of our communities and the importance of ensuring that policing remains responsive to local needs.

I want to thank my fellow Board members for their professionalism, experience, and commitment to building a strong governance culture. I also wish to acknowledge the support of municipal staff, our municipal councils, community partners, and the OPP leadership team for their continued collaboration. Strong public safety governance depends on trust, preparation, respectful dialogue, and a shared commitment to the communities we serve.

Looking ahead, the Board will continue to focus on evidence-based oversight, clear reporting, community engagement, and continuity through future Board transitions. Our goal is to ensure that the residents of Russell County continue to benefit from policing services that are accountable, transparent, and aligned with local priorities.

This Annual Report reflects a year of practical progress. It shows a Board that is moving from establishment into maturity — with stronger processes, clearer expectations, and a continued commitment to safe, thriving communities across Russell County.

PRESENTATIONS RECEIVED

- **Prescott-Russell Victim Services**

- Victim Services of Prescott-Russell is a local, non-profit organization that offers free, confidential, 24/7 help to people affected by crime or sudden tragedies, working closely with police, emergency services, and community partners.
- The organization provides immediate and compassionate support, including emotional help, safety planning, practical assistance, referrals, and follow-up care to help individuals and families recover and feel safe again.
- Services are available to victims of many situations, such as intimate partner violence, sexual violence, human trafficking, sudden loss of a loved one, suicide, harassment, elder abuse, hate crimes, fires, and serious accidents.
- In 2025, 791 people received direct support, with the greatest needs related to domestic violence, tragic events, and sexual violence; assistance often included safety measures, food, transportation, emergency housing, and financial help.
- In addition to crisis response, the organization plays an active role in prevention and community well-being, offering programs focused on human trafficking prevention, youth awareness, road safety, homelessness support (including a winter warming centre), trauma therapy, and new tools such as a victim safety mobile app.

Our Detachment

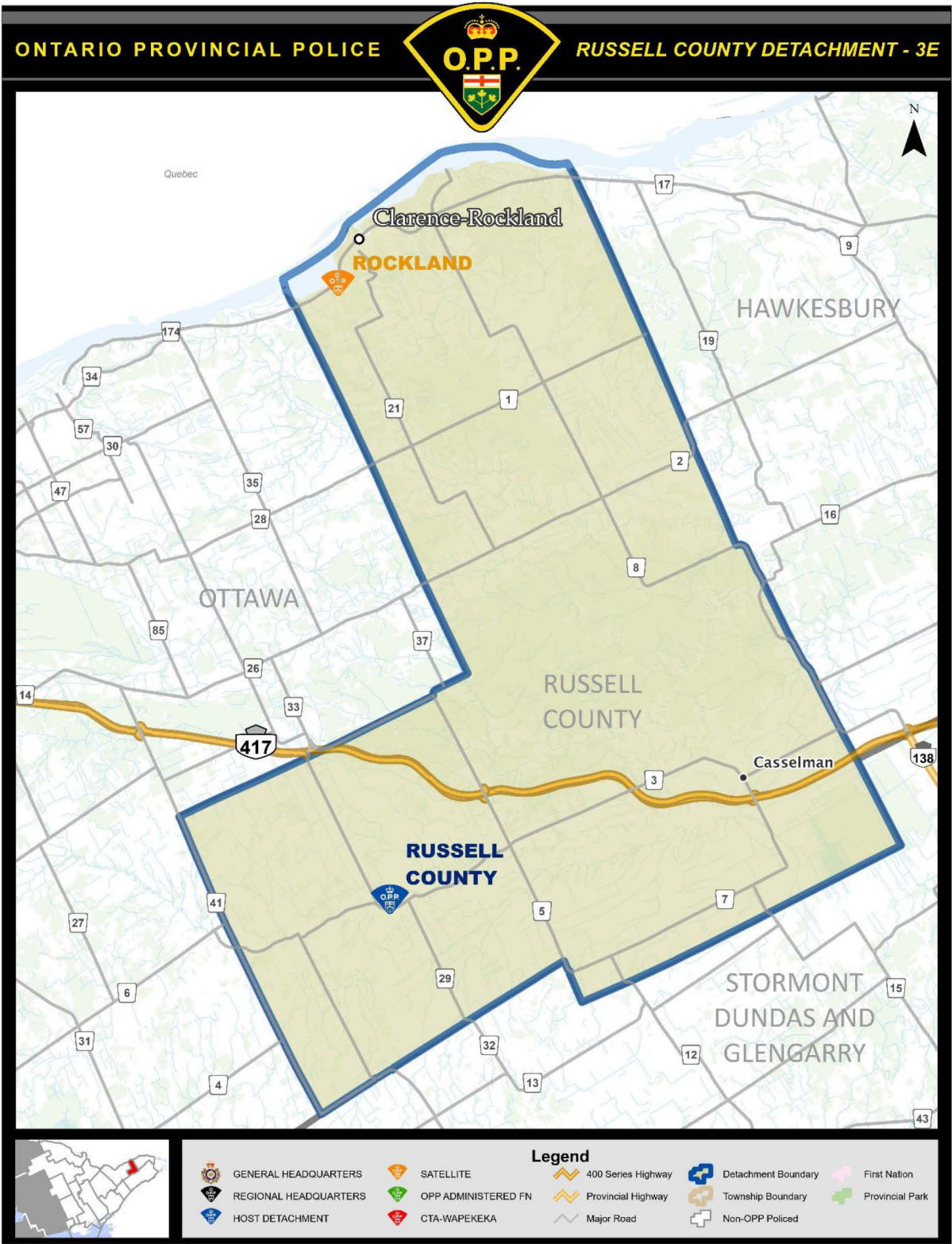
Russell County is home to four municipalities, Russell Township, The Nation Municipality, Village of Casselman and the City of Clarence-Rockland. The population of the County is approximately 75,000 and growing rapidly. According to Census information, 60 percent of the residents in Russell County are francophone with the majority being bilingual. Bordering the Ottawa River and nestled just east of the National Capital Region, Russell County's detachment area accommodates a number of travelers on two major highways, 174 (old 17) and 417.

The largest theme waterpark in Canada, Calypso Park, is located in The Nation Township. The waterpark brings thousands of visitors to our patrol area annually. We continue to work closely with park management and elected officials to address traffic, crime and safety issues to ensure those attending Russell County have a safe and enjoyable trip.

The Larose Forest, at 18,000 acres, is one of the largest man-made forests in Canada. It boasts 180 kilometres of roads and trails ideal for hiking, horse-back riding, biking, hunting or snowmobiling plus other recreational outdoor activities.

The Canadian International Hockey Academy (CIHA) located in the City of Clarence-Rockland is an internationally recognized organization which is home to over 60 international students. During daytime hours, the ice surface is dedicated to the students; however, during evenings and weekends the two ice surfaces are rented to minor hockey and other hockey associations in the area. Weekend tournaments bring an increase in local traffic and we work closely with CIHA to ensure all concerns are addressed.

These factors include: impaired driving, speeding/aggressive driving, inattentive/distracted driving, and lack of occupant restraints. Increased visibility and enforcement activities on our highways, trails and waterways will lead to safer roads and improve community safety.

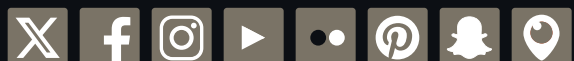

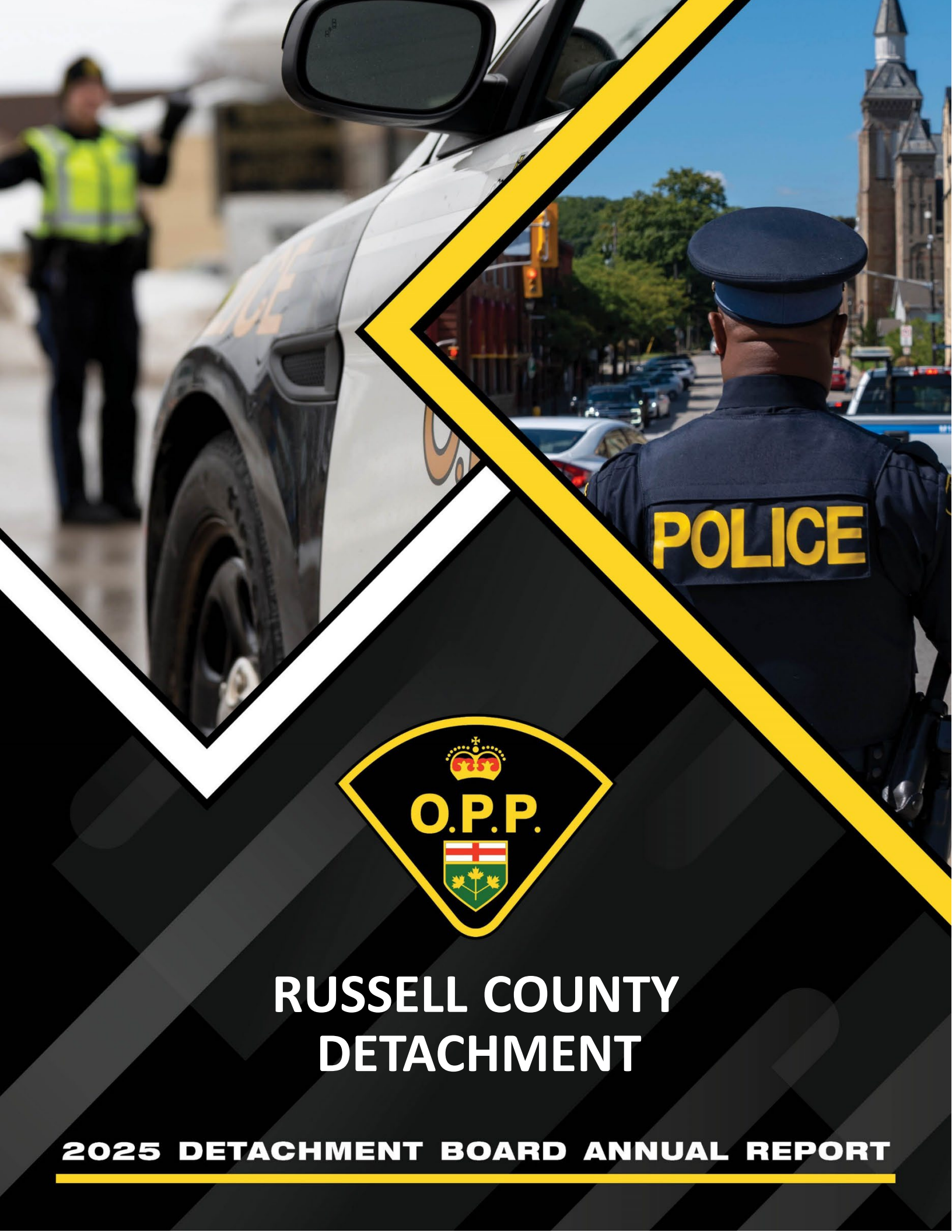

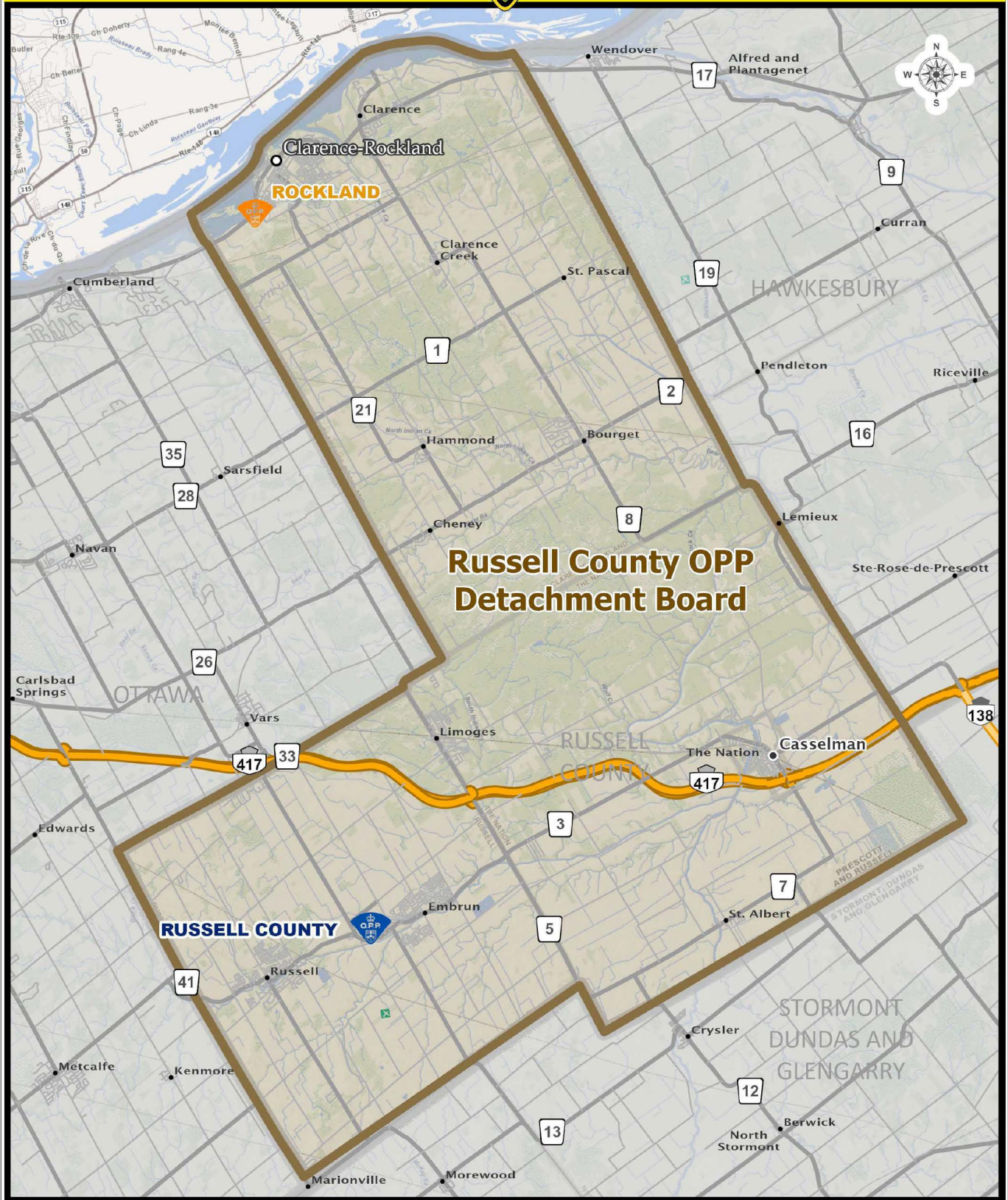

Message from the Detachment Commander

I am pleased to present the Russell County Detachment – 2025 Detachment Board Annual Report. This report provides an overview of crime and traffic trends, community well-being data, and highlights key initiatives and accomplishments achieved by our members throughout the past year.

The year 2025 marked the final year of the 2023–2025 Russell County Detachment Action Plan, and this report reflects both our progress toward those objectives and the outcomes achieved in collaboration with our policing and community partners.

I am proud of the professionalism, dedication, and commitment demonstrated by the women and men of the Russell County Detachment in service to our communities.



Operational Overview

Throughout 2025, the detachment responded to a wide range of calls for service reflecting the diverse needs of our urban and rural communities. We experienced increases in demand in certain areas of crime and public safety, and our response remained focused on timely investigations, proactive enforcement, and victim-centred policing.

Traffic safety continued to be a priority for the detachment. Members focused enforcement efforts on high-risk driving behaviours, including speed, impaired driving, and aggressive driving. These targeted initiatives were supported by patrol visibility and data-informed deployment, contributing to safer roadways across Russell County.

The detachment also responded to significant and complex incidents during the year, requiring coordinated responses, investigative rigor, and strong partnerships with emergency services and municipal stakeholders. These events highlighted the professionalism of our members and the importance of preparedness and collaboration.

Community Engagement and Partnerships

Guided by community feedback, we increased patrols and engagement in areas where residents expressed public safety concerns. Through visible policing and direct interaction, members worked to address local issues while strengthening trust and confidence in policing services.

We continued to leverage technology, including body-worn cameras, in-car video systems, and automated licence plate recognition (ALPR), to support evidence collection, enhance transparency, and improve public and officer safety.

Collaboration remained a cornerstone of our work. The Russell County Detachment worked closely with our policing partners, including municipal and regional services, to support cross-jurisdictional initiatives and ensure seamless service delivery.

We also strengthened partnerships with community-based organizations to support vulnerable persons. Through collaboration with health and social service partners, we enhanced our response to mental health-related calls and worked to connect victims of crime with local resources and supports.

Members remained actively engaged within the community, attending local events, participating in community safety initiatives, and engaging with schools, service clubs, and community groups. These interactions are essential to building relationships, fostering understanding, and supporting community well-being.

Supporting Our Members

Supporting the growth and well-being of our members remained a priority. Throughout 2025, detachment members participated in training, professional development, and wellness initiatives designed to enhance operational effectiveness, resilience, and leadership capacity.

Looking Ahead

In 2026, the Russell County Detachment will release its 2026–2029 Russell County Detachment Action Plan. This will be the first detachment action plan developed under the *Community Safety and Policing Act* (CSPA). The development of this plan is being undertaken in close collaboration with the Russell County Detachment Board and through engagement with community members to ensure the priorities, concerns, and needs of our communities are reflected in the commitments we make for the next four years.

The development of the 2026–2029 Russell County Detachment Action Plan will coincide with the creation of the 2026–2029 OPP Strategic Plan, ensuring alignment between local priorities and organizational objectives.

As we look ahead to emerging challenges and new opportunities in policing and community safety, the members of the Russell County Detachment remain committed to our mission to serve our communities, protect our citizens, uphold the law, and preserve public safety.

Policing Hours

The OPP has developed a Service Delivery Model (SDM) in response to several reviews and audit recommendations. The SDM is designed to:

- Promote officer wellness through balanced workloads
- Determine adequate staffing levels at each detachment
- Ensure the continued delivery of adequate and effective policing services in accordance with the *Community Safety and Policing Act (CSPA)*

To support SDM implementation, the OPP is undertaking a multi-year staffing strategy to address required increases in detachment personnel. This model supports the OPP’s ability to:

- Respond effectively to increasing calls for service
- Maintain safe communities through proactive patrols and community engagement
- Meet municipal expectations for police visibility

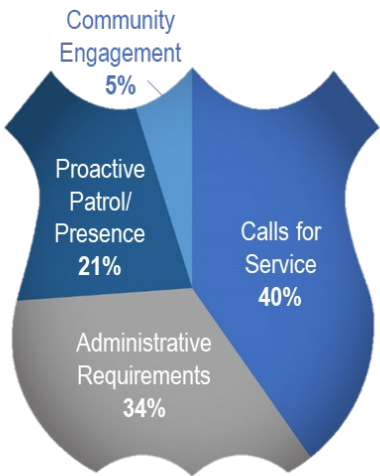


Figure 1: Service Delivery Model Provincial Target

To monitor progress and guide detachment-level planning, the OPP has established time allocation targets for provincial constables (Figure 1). These targets reflect how time should ideally be distributed by the end of the SDM staffing strategy.

The targets are based on a provincial average, and variations are expected between detachments due to differences in geography, operational structure, recruitment and leave of absence rates.

Detachments may face challenges in achieving these targets, but progress is expected as scheduling, data quality and strategic deployment continue to improve.
